2. TRUSTEES:

- b. The Trustee nominated shall hold the office of the Trustee for a period of three years for the date of nomination comming into effect.



- c. After the expiry of the time stated above the Managing Trustee may nominate them once again or appoint somebody else whom she may choose for the benefit of the purpose of the Trust.
- d. The head of Board of Trustees shall be nominated by the Provincial Council as per the statutes and directory of the Holy Family Congregation.
- e. The "Donor Trustee" shall have the power to remove any of the Trustees, if any of the Trustees act in a manner detrimental to the interest of the institution and Trust. Such removal should be after the due notice to the person concerned. In such case the settlor shall the power to appoint any other person in the place of the person removed.
- f. The nominated trustee may retire from the Trust if she wishes to do so by a notice of three months in writing to the Managing Trustee and in such an event the settlor will have the power to nominate any person to be in that place.

3. NUCLEOUS OF THE FUND:

The Trust is established with a nucleous (corpus) contribution of b.1,000 (one thousand only) bb the "Donor Trustee" in cash to carry out the objects of the Trust.


6. ACCOUNTS:



- C. The benefits of the Trust shall be open to all irrespective of cast, creed, clour or religion.


To attain the above said objects the Trust is authorised

The trustees shall hold and conduct meetings at such intervals as they may decide and records shall be maintained as provided in the constitutions of the congregation of Holy Family.


The Quorum at such meeting shall for the time being is three, Decisions whereas shall be taken by majority board unless otherwise provided here in.






POWERS AND DUTIES OF THE TRUSTEES:-9.

- a) To gather funds towards corpus or otherwise for the Trust by way of donations, grants, subsidies or otherwise from Governments, Corporation or institutions or indiciduals native or foregn either in camh or in any kind, for the purpose of the Trust.
- b) To spend the income earned or the income of the future for any or all of the objects of the Trust, either directly or by contributing to other genuine institutions to be spent for the purpose of the Trust.
- c) To accumulate income if necessary for attaining the objects of the Trust in future and to set spart the whole or part of the income for the corpus of the Trust fund for any of the objects of the Trust.
- d) To take loan from any person, banks or institutions with or without interest whether pledging assets of the Trust or otherwise in the best interest of the Trust.
- e) To acquire, alter, extend, demolish any of it's assets and even to dispose off the same in the best interest of the Trust .
- f) To sell, alter, vary, transpose , dispose off, alienate or otherwise deal with any property movable and immovable comprising the Trust fund or any investments representing the same and to re-invest the same in any market the fru rustees No. 8. 20 rexied - 30. may think fit.

POWERS AND DUTIES OF THE SISTER SUPERIOR:


- a) To manage, control and supervise the day to day affairs/ management of the properties now or herein-after belonging to the institution of the Trust and develop them.
- b) To enter into any contract or agreement for and on behalf of the Trust for any of the purpose concerning to routine activities/affairs of the institutions of the Trust which are beneficial to the interest of the Trust.
- c) To appear and act for and on behalf of the Trust in all legal proceedings before any compentent authority.
- d) To appoint and constitute advocates or other attorneys whenever necessary and to remove them whenever she feels such act is necessary.
- e) To take loans or borrow money, as decided by the Board of Trustees and to execute promissory notes, bonds or the like for the sax same and to discharge the same by repayments.

expenses, reasonably and ligitmately incurred by them in connection with the Trust matters and incurred for attending any meeting of the Trustees or any committee thereof, save as aforesaid, the Trustees including the Managing Trustee shall not be entitled to any remuneration for serving as such. Provided that the Trustees may employ any of the Trustees being engaged in any profession or business (or in any form of which we shall be member to act of business which a person engaged in that progession or business can do) and may pay such charges for the act or business done by her or her firm as aforesaid as she or they may make or recover if the Trustee or whose firm may be so employed was not a Trustee.

DISSOLUTION AND RETIREMENT OF THE TRUSTEES:

a) When the Trustees feel that in the best interest of the public it is better to wind up the Trust and the object can be better acheived by any other manner, they shall submit the proposal to the Provincial Concil of the congregation of the Holy Family and if permitted, the assets remaining as on the date of winding up, shall under no circumstances be distributed among the Trustees but same shall be transferred to another charitable Trust/ society; whose objects are similar to those of this Trust and which enjoys recongnition, Under section 80(G) of the Income Tax Act 1961 as amended from time to time.

- c) A Trustee shall automatically cease tobe and shall vacate the Office of the Trustee on the happening of any one of the following: By death, resignation or retirement, if she becomes of unsound mind, if she is adjudged insolve or if she applies to be so adjudged.

13. AMENDMENT:

The Members of the Trust are competent to amend, alter, add to or bring about change in any manner to the terms of this Deed. However no amendments to this Deed of Trust shall be made which may prove tobe repugment to the provisions of section 2(15) 11, 12, 15 and 80(G) of the Income Tax A_ct, 1951 as amended from time to time. Further no amendment shall be carried out without the prior approval of the Commissioner of Income Tax.


